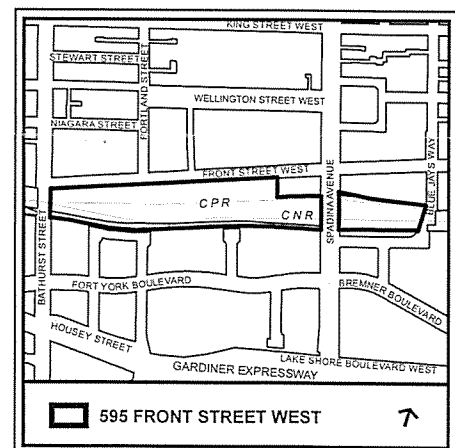
Proposal
